CITY OF HARRODSBURG BOARD OF COMMISSIONERS MINUTES FOR REGULAR MEETING

DATE: March 10, 2025

TIME: 12 p.m.

PLACE: City of Harrodsburg, Conference Room

Mayor Robert "Bob" Williams called the regular meeting to order at 12 p.m. Members present, Commissioners; Kerry Anness, Charlie Mattingly, Jack Coleman and Marvin "Bubby" Isham (came in around 12:05 p.m.).

ROLL CALL

Commissioner Anness – Present; Commissioner Mattingly – Present; Mayor Williams – Present; Commissioner Coleman – Present; Commissioner Isham – absent during roll call; however, he came in around 12:05 p.m.

MICHELLE EASTHAM, CAMPBELLSVILLE UNIVERSITY, DIRECTOR OF ALLIED HEALTH PROGRAMS SPOKE

Ms. Eastham came to announce some new things coming to Campbellsville University Harrodsburg Campus. She said they will be offering the Emergency Medical Technician Program will be offered this fall. She said that program is a 200-clock hour program and will start in August and finish in March. Ms. Eastham said that program is work ready scholarship eligible. She said they will be adding a paramedic program in the future. Ms. Eastham thanked the Fire Department for supporting the program and working with her to get it going.

DIANE MAYS SPOKE

Ms. Mays lives at 415 Linden Ave and came to voice a complaint. She said the water rolls down the hill from the hospital. The water goes down her driveway. Ms. Mays said this last rain we had got into her basement, it knocked her furnace out, knocked her water heater out. She said they tried to fix it in the past. Ms. Mays said when they would come clean it out the water would run through. Commissioner Mattingly said when Leo Vaughn was here, they worked on it and put in a drain. He said it works unless you have a hard rain coming off that hill. Commissioner Mattingly said he doesn't see a way to detour that water. Ms. Mays said the drain needs to be cleaned out. She said her request is they clean it out. Commissioner Mattingly asked CAO Maynard if we could get somebody up there to clean it out. Ms. Maynard said she is sending a text message right now. She said if they would at least come once a month to keep it cleaned out. Mayor Williams said he went up there and looked at it and it looks like there may have been a storm drain outlet there but there is a metal plate across it. He said he never knew what that was about. Mayor Williams asked Ms. Maynard to have Frank check on that. Mayor Williams said they will have the street department look at it.

DAARIK GRAY, TOURIST COMMISSION SPOKE

Mr. Gray came asking for street closures. He said they are excited to partner with the Chamber of Commerce to bring back the Christmas Parade. The event will start on Broadway, go around Fort Harrod Parking lot, go across 127, all the way to right in front of where the Harrodsburg Herald used to be, turn up toward Main Street, all the way up Main Street, down Mooreland and Chiles then back up and turn left to 127. He said that evening in Old Town Park they will have a Christmas tree lighting ceremony and live music. He said technically the Chamber will be over the parade. He said they will start closing streets off early that morning. The event will be Friday, December 5th. He said they will probably put food trucks on Poplar.

Mr. Gray said they are going to partner with the Jazz Festival kick up. Street closures will be the same as Friday Nights on Main. Closures will be from 3:30 p.m. to 10 p.m. on Friday, October 10th.

Mr. Gray said the Tourist Commission has agreed to take over the Oktoberfest events. He said the original committee decided not to continue with it, but as important as it is to our community, they wanted to take it over. Mr. Gray said he is not sure if they are going to do the full three days, they have looked at possible going down to just Friday and Saturday. They are going to keep the dates the same until they work out things. He said it is the same exact streets as it has been. From 68 to Mooreland, Chiles Street beginning on Thursday, September 25th at noon until Sunday night at midnight. He said they may not need that Sunday, but just in case. He said the dates were set and they get a lot of questions about why is it in September. Mr. Gray said not to create any more confusion they are just going to stick with the dates the original committee picked.

Roll call vote was taken and recorded as follows: Commissioner Anness – Yes with the emphasis being the city may but not necessary will turn off water at resident's home. He said they talked about it at last meeting; Commissioner Mattingly – Yes; Mayor Williams – Yes; Commissioner Coleman – Yes; Commissioner Isham – Yes. Motion passed.
